**SUBJECT: Renewal of Mohawk Ambulance Service Contract**

**Background Information:** The Schenectady Fire Department (SFD) and Mohawk Ambulance Service (MAS) have had a working relationship in providing medical services to the City of Schenectady for over 40 years. SFD is the primary paramedic service in the city while MAS provides assistance and transportation. The contract between both parties is for a three-year period and is currently at the end of its term.

**Evaluation/Analysis:** The proposed 2023 contract is identical to the previous contract with one minor exception. In item number 17, the amount of time that each party has the ability to cancel the agreement goes from a 60 day period to a 90 day period. Corporation Council does not object to this change. No other changes have been made to the agreement by either party.
